

The Central Brampton Family Health Team (CBFHT) is a not-for-profit organization that receives funding from the Ministry of Health and Long-Term Care to provide quality primary health care services to over 10,000 patients in the Brampton area. In addition, Central Brampton FHT is working towards expanding team-based care to Bramalea Region in 2019.

### **Skills**

**The ideal candidates will have the following knowledge, skills and attributes**

- Strong legal background that relates to PHIPA (Privacy) and Employment Law
- Quality Assurance planning in health care setting experience;
- Experience on corporate or non-profit Boards of Directors with an understanding of the roles and responsibilities of a Governance Board;
- Demonstrated leadership in their profession/business;
- Live and/or work in Brampton/Bramalea region Peel
- Willingness to commit time and energy and participate in approximately 6-8 daytime board meetings a year, for a 3-year term.

### **Qualifications**

**Every director shall:**

- 1) Be eighteen (18) or more years of age;
- 2) Directors/Members must fulfill the requirements and responsibilities of their position, including, preparing for and attending board and committee meetings, upholding their fiduciary obligations and working cooperatively and respectfully with other Board members;
- 3) Directors/Members must comply with By-Laws governing CBFHT, policies and procedures, and all other applicable rules;

- 4) Not hold a paid position with the organization and not enter a contract for services with the organization;
- 5) Be a person interested in furthering the objectives of the organization;
- 6) Not be of unsound mind or have been so found by a court in Canada or elsewhere;
- 7) Not be an un-discharged bankrupt

This is a volunteer role with no remuneration for this position.
